Det er rigtigt, at der ligger et forslag om at rive boligerne på Langhusvej ned i strategien for Tingbjergs udvikling. Husene er i sådan en stand, at de enten skal totalrenoveres, hvis de skal bevares, eller også skal der findes andre løsninger.

Men der er altså tale om et forslag – ikke en beslutning. Beslutningen tages tidligst i slutningen af 2018.

Sidst i august vil fsb's medarbejdere kontakte jer for at aftale personlige møder. Vi vil gerne tale med jer om de idéer, der er for Langhusvej - og ikke mindst jeres ønsker.

## Dear residents at Langhusvej

Currently there are a lot of plans and ideas concerning the development of Tingbjerg. The reason is that fsb, SAB and Copenhagen Municipality are working together on how to make the strategy for the development of Tingbjerg a reality. In 15-20 years the Tingbjerg area should be characterised by more residents, new types of residences, better city life with more stores, more roads going in and out of Tingbjerg as well as better public transportation.

The many plans and ideas might cause uncertainty with the residents in Tingbjerg – not least with you, who live at Langhusvej. Therefore, we would like to emphasize that a decision to tear down your residences has NOT been made.

However, it is correct that there is a suggestion to tear down the residences at Langhusvej as part of the overall strategy of the development of Tingbjerg. The buildings are in such state that they either have to go through a total renovation, if they are to be preserved, or else other solutions have to be identified.

But this is only a suggestion – NOT a decision. The decision will be made no earlier than the end of 2018.

At the end of August 2018 employees from fsb will contact you to arrange personal meetings. We would like to talk to you about the suggested ideas for Langhusvej – and especially about your wishes.
